HAINES ELECTED MSRPS TRUSTEE



Having retired from the *Prince* George's County Public Schools in 2016. Kenneth B. Haines completed his second term in June of 2017 as an elected Trustee for the Maryland State Retirement & Pension System representing active employees.

During his quarter-century in

majority Free-and-Reduced Lunch high schools, his Advanced Placement students maintained a 70% pass-rate on the rigorous French Language Advanced Placement Examination as he created and shared Cooperative Learning materials countywide and integrated Information Technology into the instructional program.

His decades of activism for the Prince George's County Educators' Association would afford him opportunities to serve as member of NEA Resolutions for six years, twice as MSEA Resolutions Co-Chair, and six times as Convention Chair of the NEA Fund for Children and Public Education. From 1998 through 2015, he was a member of the PGCEA Negotiations team, and was charged with analysis of the cost implications of salary proposals and benefits packages totaling \$700 million for 9,000 educators. He would also lead a successful effort to restructure the pay scale improving career earnings for members of the unit, and eventually serve two terms as local president.

Having obtained the endorsement of delegates to the MSEA Convention and the MRSPA Board of Directors, Kenneth is now seeking your vote to become the elected Trustee on the MSRPS Board of Trustees representing retirees. (Since this writing, Mr. Haines has been declared the only candidate and approved as the successor to Theresa Lochte.)

NOTES ON FY 2020 BUDGET

General Comment

- 1. The Proposed Budget reflects a conservative and realistic expression of anticipated Income and Expenses for the Fiscal Year July 1, 2019 June 30, 2020.
- 2. The Proposed Budget corrects previous under estimates for expense of ongoing activities by using actual expenditures, e.g. Annual Meeting
- 3. The Proposed Budget resolves the longstanding issue of MRSPA spending dues received in the current year for membership in the following year. This modification to the cash basis of accounting has been cited as a concern by our auditors, as it budgets based on next year's membership but only realizes dues paid after July 1. The previous practice, of billing cash paying members for next year's membership dues in the Spring of the current year, and then using those dues payments when received rather than in the next fiscal year will be discontinued.
